The Action Cycle shows how to create healthy communities. The rankings later in the document assist in understanding what makes a healthy community.

# 2023 Community Health Needs Assessment

#### **Collaborators**

HH Health System-Lincoln, Inc., as the sponsors of the assessment, engaged national leaders in community health needs assessments to assist in the project. Stratasan, a healthcare analytics and services company based out of Nashville, Tennessee, provided the analysis of community health data and facilitated the focus groups.

# **Community Input and Collaboration**

#### Methods and Dates

In January 2023, HH Health System-Lincoln began a Community Health Needs Assessment for Lincoln County and sought input from persons who represent the broad interests of the community using several methods:

- Information gathering, using secondary public health sources, occurred in February 2023.
- Community members participated in focus groups for their perspectives on community health needs and issues on February 23, 2023.

# Participants by Those Representing the Broad Interests of the Community

Twenty-two individuals from twenty-one community organizations participated in the focus groups aimed at identifying and defining significant health needs, issues, and concerns of Lincoln County. The three-month process centered on gathering and analyzing data, as well as receiving input from persons who represented the broad interests of the community, to provide direction for the community and hospital to create a plan to improve the health of the communities.

# Input of the Medically Underserved, Low-Income, and Minority Populations

Input of medically underserved, low-income and minority populations was received though focus groups. Agencies representing these population groups were intentionally invited to the focus groups.

# Input on the Most Recently Conducted CHNA and Most Recently Adopted Implementation Strategy

HH System-Lincoln, formerly known as Lincoln Health System, was a county-owned hospital and therefore not required to conduct a CHNA. They became a 501(c) 3 in 2022.

### **Process and Methods Used**

# **Community Selected for Assessment**

Lincoln County was the primary focus of the CHNA due to the service area of HH Health System-Lincoln. Used as the study area, Lincoln County provided 86.3% of January 1, 2022, through December 31, 2022, inpatient discharges. The community includes medically underserved, low-income, and minority populations who live in the geographic areas from which HH Health System-Lincoln draws their patients.

All patients were used to determine the service area without regard to insurance coverage or eligibility for financial assistance under HH Health System-Lincoln's Financial Assistance Policy.

#### Data and Other Information Used in the Assessment

#### Secondary methods included:

- Public health data death statistics, County Health Rankings, cancer incidence
- Demographics and socioeconomics population, poverty, uninsured, unemployment
- Psychographics behavior measured by spending and media preferences

#### **Information Gaps**

While this assessment was quite comprehensive, it cannot measure all possible aspects of health in the community, nor can it adequately represent all possible populations of interest. It must be recognized that these information gaps might in some ways limit the ability to assess all the community's health needs.


## Race and Ethnicity

#### Percent of Population by Age Group



- The population of Lincoln County is projected to increase from 2022 to 2027 (0.21% per year). Tennessee is projected to increase 0.52% per year. The U.S. is projected to increase 0.25% per year.
- The 65+ population will comprise a larger percentage of total population by 2027.
- Lincoln County had a higher median age (43.4 median age) than TN (40) and the U.S. (38.9). In Lincoln County the percentage of the population 65 and over was 21%, higher than the U.S. population 65 and over at 17.5%.
- Lincoln County median household income at \$57,843 was lower than TN (\$61,059) and the U.S. (\$72,414). The rate of poverty in Lincoln County was 14.6% which was higher than TN (13.7%) and the U.S. (12.8%).
- The household income distribution of Lincoln County was 21% higher income (over \$100,000), 55% middle income, and 24% lower income (under \$25,000). The largest income group is the 19% making \$50,000 to \$74,999.
- The health care index measures how much the populations spent out-of-pocket on health care services including insurance premiums. The U.S. index was 100. Lincoln County was 91, indicating 9% less spent out of pocket than the average U.S. household on medical care (doctor's office visits, prescriptions, hospital visits) and insurance premiums.
- The cost of living in Lincoln County was 20% less than the U.S. and 9.9% less expensive than TN.
- The racial and ethnic make-up of Lincoln County was 85% White, 6% Black, 4% Hispanic origin, 6% more than one race, 1% Asian/Pacific Islander, and 1% other. (These percentages total to over 100% because Hispanic is an ethnicity, not a race.)



#### 2022 Population by Census Tract and Projected Change (2022-2027)






Census tracts generally have a population size between 1,200 and 8,000 people, with an optimum size of 4,000 people. The higher populated census tracts are smaller geographically and the less populated census tracts are larger in geography. The highest populated census tracts are west Fayetteville and two tracts in the southeast corner including New Hope and Elora

The majority of Lincoln County has growth ranging from .1% - 0.69%. However, some tracts project population decline, west Fayetteville, a tract in the southwest corner including Taft and the tract including New Hope.

### 2022 Median Age, Income, and Households Making Less Than \$15,000 per Year





The top two maps depict median age and median income by census tract. Looking at age and income by census tract is helpful to demonstrate all areas of a county are not the same. The health needs may be very different in the census tract in northeastern Lincoln County with a higher median age of 50 than the tract south of Fayetteville with a median age of 40.


Looking at median household income by census tract also gives insight into health status. The lower income areas may require more resources than the higher income tracts. The western census tracts with a higher median household income of \$77,000 will probably have different needs

than that of the tract in the heart of Lincoln County making \$46,000.

The lower map is the number of households making less than \$15,000 per year. Again, further attempting to identify those areas within the county that may have a lower health status. The census tract located in the middle of the county shows 528 households making less than \$15,000 per year.

#### **Economic Indicators**

#### Percent in Poverty 2021



Lincoln County's 2021 poverty percentage was 14.6% compared to TN at 13.7% and the U.S. at 12.8%. The cost of living in Lincoln County was 10% lower than TN and 20% lower than the U.S.



Retail, accommodation, and food service offer health insurance at a lower rate than healthcare, public administration, and educational services.

Lincoln County's December 2022 preliminary unemployment was 3% compared to 3.5% for both Tennessee and the U.S.





# Psychographics - Tapestry Segmentation

Demographics are population, age, sex, and race. Psychographics are adding behavior data in the form of spending habits and survey data combined with demographics. Sixty-eight percent of Lincoln County are included in three Tapestry Segments. The map below is color coded by LifeMode, which are groupings of Tapestry Segments that behave similarly. The dominant Tapestry Segment of each census tract is identified by number and name.

The dominant Tapestry Segments in the county were Rooted Rural (33.6%), Southern Satellites (21.2%), and Salt of the Earth (13.5%).

There is a very brief description of the segments on the right of the map. There is much more information on Tapestry Segments, at http://doc.arcgis.com/en/Esridemographics/data/tapestry-segmentation.htm. Analyzing the Tapestry Segments in the study area helps determine health habits, technology, and communication preferences of residents, enabling more effective communication and implementation of solutions to improve health. Many spoke of meeting people where they are in the focus group. Studying their Tapestry Segment can help do that.

# **Focus Groups Summary**

Community stakeholders representing the broad interests of the community as well as those representing low income, medically underserved, and minority populations participated in two focus groups on February 23, 2023, for their input into the community's health. Community participation in the focus groups represented a broad range of interests and backgrounds. Below is a summary of the focus groups.

The participants defined health as a state of wellbeing – physical, emotional, spiritual, and mental with a good quality of life. They believe the health of the county could be better.

The most significant health issues for the communities were:

- Mental health depression, suicide, access to resources
- Substance misuse Meth, alcohol, prescription drugs, fentanyl, vaping, nicotine
- Poor eating habits
- Access to healthcare doctor availability, specialists, dentists, cost of care, undiagnosed issues, only two physicians who see TennCare babies, cost of care, uninsured
- Poor educations, poor decision-making
- Preventive care
- Obesity
- Healthy, safe youth activities
- Parenting time, poor parenting
- Lack of childcare
- Food insecurity

If given a magic wand and no resource restrictions, the participants selected the following solutions to improve health.

- Communication increase public awareness
- Lower cost of services health, dental, copays, medications
- Transportation
- More money and taxes
- Clean and enhance parks
- Get together more often as a group to come together, collaborate and talk
- Child welfare focus
- Mental health counsellors in all schools
- Civic center for youth and adults with a swimming pool
- CAC exam rooms and counsellors
- Repurpose buildings to have all resources and services under one rough
- Substance abuse recovery center
- Buy-in, health literacy and education

# **Health Status Data, Rankings, and Comparisons**

#### Health Status Data

Based on the 2022 County Health Rankings study performed by the Robert Wood Johnson Foundation and the University of Wisconsin<sup>2</sup>, Lincoln County ranked 48th out of 95 Tennessee counties ranked for health outcomes (1= the healthiest; 95 = unhealthiest), and 36th for health factors. Health outcomes are composed of length of life and quality of life. Health factors are comprised of health behaviors, clinical care, social & environmental factors, and physical environment. To become the healthiest community in TN and eventually the nation, Lincoln County must close several lifestyle gaps.

County Health Rankings suggested the areas to explore for improvement in Lincoln County were:

- higher adult smoking
- higher percentage of adult obesity
- higher uninsured
- lower percentage of high school completion
- lower percentage of some college
- higher percentage of violent crime

#### The strengths were:

- higher food environment index
- lower percentage of excessive drinking
- lower preventable hospital stays
- higher flu vaccinations

When analyzing the health status data, local results were compared to TN, the U.S. (where available), and the top 10% of counties in the U.S. (the 90th percentile). For additional perspective, TN was ranked the 43<sup>rd</sup> healthiest state out of the 50 states. (Source: 2020 America's Health Rankings; lower is better)

#### TN challenges were:

- High premature death rate
- High prevalence of multiple chronic conditions
- High prevalence of cigarette smoking

#### The <u>strengths</u> were:

- Low prevalence of excessive drinking
- High supply of primary care providers
- Low percentage of households experiencing severe housing problems

Information from County Health Rankings and America's Health Rankings was analyzed in the CHNA in addition to the previously reviewed sociodemographic information and other public health data. Other data analyzed is referenced in the data below, such as: causes of death, demographics, socioeconomics, consumer health spending, and primary research. If a measure was better than TN, it was identified as a strength, and where an indicator was worse than TN, it was indicated as an opportunity for improvement. To prevent strengths from becoming

opportunities for improvement, it's important to continually focus on them. Opportunities were denoted with red titles, and strengths were denoted with green titles for easy interpretation. The years displayed on the County Health Rankings graphs show the year the data was released. The actual years of the data are contained in the source notes below the graphs.

<sup>2</sup> The Rankings are based on a model of population health that emphasizes the many factors that, if improved, can help make communities healthier places to live, learn, work and play. Building on the work of America's Health Rankings, the University of Wisconsin Population Health Institute has used this model to rank the health of Tennessee's counties every year since 2003.

In most of the following graphs, Lincoln County will be navy blue, TN will be purple, U.S. will be teal and the 90th percentile of counties in the U.S. will be blue.


#### Health Outcomes (Length of Life and Qualify of Life)

Health Outcomes are a combination of length of life and quality of life measures. Lincoln County ranked 48<sup>th</sup> in health outcomes out of 95 Tennessee counties.

#### **Length of Life**

Length of life was measured by years of potential life lost per 100,000 population prior to age 75; here, lower is better. For example, a 25-year-old killed in an accident equates to 50 years of potential life lost prior to age 75. Lincoln County ranked 65<sup>th</sup> in length of life in TN. Lincoln County lost 11,558 years of potential life per 100,000 population which was higher than TN and the U.S.

Lincoln County residents can expect to live 4.9 years less than the average U.S. resident.




Lincoln County's suicide rate was above TN and the U.S.; however, the trend is declining.

## **Quality of Life**

Quality of life was measured by: % reporting fair or poor health, the average number of poor physical health days and poor mental health days in the past 30 days, and % of live births with birthweight less than 2500 grams, or 5.5 lbs. Lincoln County ranked 26th in quality of life out of 95 Tennessee counties. Quality of life and health behaviors both ranked 26 out of 95 counties and are the highest (best) ranks of all the categories for Lincoln County.

#### **Health Factors or Determinants**

Health factors or determinants rankings are comprised of measures related to health behaviors (30%), clinical care (20%), social & economic factors (40%), and physical environment (10%). Lincoln County ranked 36<sup>th</sup> in health factors out of 95 Tennessee counties.


#### **Health Behaviors**


Health behaviors are made up of nine measures and account for 30% of the county rankings. Lincoln County ranked 26th in health behaviors out of 95 counties in Tennessee. Although Lincoln County's percentage of obesity was 37%, which is high, the percentage is equal to TN. Lincoln County's health behavior issues are physical inactivity, access to exercise opportunities, smoking, alcohol impaired driving deaths, and teen birth rate.





Food insecurity is the % of the population who did not have access to a reliable source of food during the past year.







#### **Clinical Care**

Clinical care ranking is made up of seven indicators, and account for 20% of the county rankings. Lincoln County ranked 30<sup>th</sup> in clinical care out of 95 Tennessee counties. The clinical care issues are the higher uninsured, diabetes prevalence, mammography screening, high population to primary care physicians, dentists and mental health providers. Although Lincoln County had a higher percentage of flu vaccinations than TN, the COVID-19 vaccination rate was lower than TN.







- Lacking in some areas
  - Challenges, some bad
  - Students get meals at school shower, hygiene items, significant number in that hoat
